PRESENTERS

(In alphabetical order)

Dr. Aldyth Buckland is an Associate lecturer in the Department of Community Health and Psychiatry, UWI and has her own Private Practice. She has Master Practitioner certifications in Neuro- Linguistic Programming, Hypnosis, Time Techniques, CORE Coaching and Emotional Freedom Techniques. Currently, represents the Caribbean College of Family Physicians on the Caribbean Regional Hub of the

Planetary Health Alliance, is Immediate Past President of the CCFP Jamaica Chapter and Vice-President of the Association of General Practitioners of Jamaica.

Dr. Paul Cadogan is a veterinarian, a 1987 graduate of the Ontario Veterinary College, University of Guelph, Ontario, Canada working in private clinical practice with over 30 years experience covering multiple species from pets, through food-producing animals and horses to exotics, including marine mammals. He is a Local Veterinary Inspector for the Veterinary Services Division and has a certificate in Hazard Analysis & Critical Control Point (HACCP) from the European Commission's "Better Training for Safer Food" Programme (2013). He currently chairs the Board of Examiners of the Jamaica Veterinary Board and is the representative of the Jamaica Veterinary Medical Association to the Commonwealth Veterinary Association. He has assisted with UWI graduate student research projects covering Giardiasis, Ancylostomiasis, and Cryptosporidiosis. He trained as a One Health Leader in the One Health One Caribbean One Love Project.

Dr. Simon Doherty BVMS CertAqV MRQA CBiol FRSB ARAgS FRCVS is a Director of UK-based Vet Sustain, a new community interest company focussed on providing veterinary surgeons with resources and toolkits to drive sustainability in their workplaces and help their clients to improve their sustainability too. He holds a senior position at the Institute of Global Food Security, Queen's University Belfast. Prior to his presidency of the British Veterinary Association (2018-19), he was the Animal Sciences & Aquaculture Specialist for HM Government's Department for International Trade.

He has two decades of experience in veterinary practice, industry and academia, is a Certified Aquaculture Veterinarian, a Fellow of the Royal College of Veterinary Surgeons, a Fellow of the Royal Society of Biology and an Associate of the Royal Agricultural Societies. A former Chair of the UK One Health Coordination Group, Simon currently chairs the Federation of Veterinarians of Europe Food Safety & Sustainability Working Group. He is a past-president of the North of Ireland Veterinary Association and a Life Member of the Royal Ulster Agricultural Society. He is a trustee of livestock development charity, Send a Cow, and of the BVA Animal Welfare Foundation.

Dr. Susan Koenig DFES is a 1999 graduate of the Yale University's School of Forestry & Environmental Studies, is a wildlife ecologist and Director of the Windsor Research Centre in the Cockpit Country region of Trelawny. She has studied Jamaica's wildlife ecosystems, particularly those of the Cockpit Country, has numerous publications and reports, and is a strong proponent of conservation and disease surveillance. She is involved in the development of the regional rabies surveillance project. She has also been closely involved with the local veterinary community – as a presenter at several events. In 2019 she was made an Honorary Member of the JVMA.

Prof. Chris Oura is a Professor in Veterinary Virology at the School of Veterinary Medicine, UWI-St. Augustine, Trinidad. Chris is a qualified veterinary surgeon, has a PhD in Immunology and has many years research experience working predominantly on vector-borne viral and protozoal diseases. Chris has worked in many countries around the world including Mexico, Uganda, Kenya, Zimbabwe and South Africa. Before coming to the UWI-SVM in January 2012, Chris spent 8 years as head of the non-vesicular reference labs at the Pirbright Institute in the UK. He was Project Leader in the One Health One Caribbean One Love Project. He is also involved in the regional rabies surveillance project development and is a member of the Caribbean Regional Hub of the Planetary Health Alliance.

Prof. Craig Stephen DVM PhD is a clinical professor at the School of Population and Public Health at the University of British Columbia as well as a clinical professor at the Ross University School of Veterinary Medicine. He has held several One Health leadership roles including as a Canada Research Chair in Integrating Human and Animal Health, and as the founder and scientific director of the Centre for Coastal Health, the Animal Determinants of Emerging Disease Research Unit and the BC Environmental and Occupational Research Network. Most recently he was the CEO of the Canadian Wildlife Health Cooperative. He has over 200 scientific and technical papers focused primarily on emerging environmental threats, and the application of health promotion and harm reduction to One Health and environmental issues.

Dr. E. Anthony Allen MB, BS, MDiv, MRC Psych, DM (Psych) is a Psychiatrist in Kingston Jamaica. He completed medical training at the University of the West Indies, Jamaica campus, over 45 years ago as well as graduate training in Psychiatry at the Royal Edinburgh Hospital, UK, and a Masters in Divinity at Yale University.

Dr. Michael Motta C.D. is a veterinarian and a 1998 graduate of the University of Queensland, Australia. He specializes in bovine reproduction and has spearheaded the practice of embryo transfer in Jamaican cattle. He is currently Senior Veterinary Officer with the Jamaica Broilers Group and has been a member of the Jamaica Veterinary Board since 2016.

Dr. Orville Taylor is currently the Head of the Department of Sociology, Psychology and Social Work, Faculty of Social Sciences, the University of the West Indies, Mona. He is also Senior Lecturer in Sociology at UWI, Mona, and the first PhD in Sociology from Florida International University.

Dr. Earl Wright MB. BS. MPH is a Consultant Psychiatrist, Physician & Public Health Specialist. A past student of Kingston College and a medical graduate of the University of the West Indies, he completed his postgraduate medical education at Harlem Hospital/Columbia University, New York, where he did his Psychiatry Residency and was the Chief Resident.
